

Constitution of the Classical Republican Party CRP (NORPA) *Founded on the Principles of Classical Republicanism, Natural Moral Order, and Common Law*

Preamble

The Classical Republican Party formally (NORPA) is established to up-hold the principles of classical republicanism, emphasizing individual liberty, private property, and the right to self-defense, including the responsible ownership of firearms. NORPA stands for the Natural Moral Order and adheres to natural law and common law philosophy in law-making. We reject crony ideologies such as liberalism, socialism, capitalism, statism, and reserve banking, as well as any foreign power interests that undermine Australian sovereignty. This constitution outlines the party's purpose, principles, membership, governance, and candidate eligibility to ensure integrity and alignment with our values.

Article I: Purpose and Principles

1. **Purpose:** CRP exists to promote a free, just, and sovereign Australia governed by classical republican principles, prioritizing the natural moral order, individual liberties, and the common good.
2. **Principles:**
 - Protection of private property as a fundamental right.
 - Recognition of the right to self-defense, including the responsible ownership and use of firearms.
 - Adherence to natural law and common law philosophy in all law-making processes.
 - Rejection of crony ideologies (e.g., liberalism, socialism, capitalism, statism, reserve banking).
 - Opposition to foreign power influences that compromise Australian sovereignty.
 - Promotion of civic virtue, integrity, and accountability in governance.

Article II: Membership

1. **Eligibility:** Any Australian citizen who supports CRP principles and agrees to abide by this constitution may apply for membership.
2. **Rights:** Members may vote in party elections, participate in policy discussions, and attend general meetings.

3. **Responsibilities:** Members must uphold the party's principles, reject crony ideologies, and act in the interest of Australian sovereignty.

Article III: Candidate Eligibility

1. **General Requirements:** Candidates for party leadership or public office must be members in good standing, demonstrate commitment to CRP principles, and reside in Australia.
2. **Restrictions:** For the integrity of the party and the legal system, candidates may not be:
 - Practicing lawyers.
 - Former judges.
 - Former police officers.
3. **Prohibited Affiliations:** Candidates must not have affiliations with foreign powers or advocate for crony ideologies (e.g., liberalism, socialism, capitalism, statism, reserve banking).

Article IV: Governance Structure

1. **National Assembly:** Comprises all members and meets annually to set policy directions and elect the National Council.
2. **National Council:** A body of elected members responsible for day-to-day operations, policy development, and candidate selection.
3. **Party Leader:** Elected by the National Assembly to represent CRP publicly and oversee the National Council.
4. **Regional Chapters:** Local branches that coordinate grassroots activities and report to the National Council.

Article V: Policy Development

1. Policies must align with classical republicanism, natural law, and common law principles.
2. Members may propose policies at the National Assembly, which are reviewed and approved by the National Council.

Article VI: Amendments

1. This constitution may be amended by a two-thirds majority vote at the National Assembly.
2. Proposed amendments must align with CRP core principles and be free from crony or foreign influences.
